EPA's Activities

Our campaigns

Cross-Border Enforcement (CBE)

- Political campaign on new EU CBE Directive (published in March 2023) with Public Affairs consultancy Eurotran
- Look for additional EU-wide legal options / initiatives to ensure (digital) access to vehicle keeper/ holder data in support of free-flow parking (internal EPA report, June 2024)
- Collaborate with other stakeholders such as POLIS and EuroCities (incl. UVARs)

European Parking Card for people with disabilities

- Contributed to EU Commission survey by EY and partners (February 2023)
- Worked with Eurotran to ensure that the legislation (published in September 2023) includes the concerns of EPA members
- Created "shadow expert group" to engage with Commission on technical aspects

Alliance for Parking Data Standards (APDS)

- Promote APDS as the global standard for parking data sharing, facilitate its uptake by all operators and suppliers
- Expand APDS applications with stakeholders such as EV Roaming Foundation (OCPI) and Cycle Industries Europe
- Assess opportunities of establishing a 'European Mobility Data Space' for parking

EPA Manifesto

- Work with the Policy & Strategy Committee to produce an EPA Manifesto following the June 2024 EU elections
- Use the Manifesto as introduction and positioning towards new EU policymakers after September 2024 (cf. Manifestos by other associations such as POLIS, EuroCities, ACEA etc.)

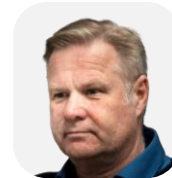
